Erwin O. Smigel Travel Awards Committee Report 2016-2017

The Erwin O. Smigel Travel Awards were established in 1975 to provide assistance to unemployed and underemployed sociologists. According to SSSP by-laws, applicants for Smigel travel awards must be sociologists with an advanced degree who are not full-time students and who are not fully employed (list of criteria below). The committee had \$1,500 to allocate with \$500 as the maximum amount that can be granted to any one recipient. The 2016-17 Erwin O. Smigel Travel Awards Committee application deadline was midnight (EDT), March 15, 2017. Committee members for this year, were Nancy Jurik, Chair, Julie A. Mikles-Schluterman, Chair-Elect, and Amanda Kahl Smith.

These were the Smigel Award guidelines:

 The Smigel Award monies are to be used to help pay for three or four unemployed or severely underemployed sociologists' transportation to and registration fees for the SSSP meeting;
Applicants must be current SSSP members who are presenting a paper at the main SSSP meeting (rather than at an adjacent workshop or meeting) or participating as a SSSP elected or appointed officer or committee member;

3) A maximum of \$500 dollars is to be granted to any one recipient. Persons unable to attend the meetings MUST return all monies to SSSP.

The Committee received nine online applications for the Smigel Award but one application was a duplicate so that left the Committee with eight applicants to consider. Of these eight, four applicants did not meet the eligibility requirements [three were 2017 student members and one was not on the 2017 SSSP program]. Therefore, the committee decided to delete those four applicants [i.e., Green, Laberge, Rothmuller, Stevens], and to consider only the remaining four applicants for funding [Asbury, Dergousoff, Engeman and Szetela]. In other words, the Committee did not award any amount to applicants who were not on the program or had not paid current SSSP dues.

Michele Koontz provided the Committee with a spreadsheet of the applications which included three columns that she added to the spreadsheet for 1) SSSP Membership Status, 2) Program Participation, and 3) Received Funding in 2016. A copy of this spreadsheet is attached. The committee decided to make awards to the four applicants who were eligible for funding. In determining the amount awarded to each of the four recipients, the committee factored in the distance that would be traveled to the conference. More specifically, the Committee looked at the four applicants who met awards criteria and offered more to the applicant coming from another country who faced a higher airfare. We made this decision to be consistent with SSSP's expressed desire to encourage more international participation in its annual meetings. We divided the remaining monies among the other three applicants who were traveling from distances that we deemed closer or more in line with domestic fares. We advised Michele Koontz of our decision in late March and she contacted applicants and recipients to inform them of the Committee decisions.

In summary, the committee made the following awards:

Cassandra Engeman received \$500; Kathleen Asbury received \$333; Deborah Dergousoff received \$333; Adam Szetela received \$333. I would like to thank the Smigel Committee members-- Julie A. Mikles-Schluterman, Chair-Elect, and Amanda Kahl Smith--and Michele Koontz for their work on these awards decisions.
