## Re: SSSP 2019-2020 Nominations Committee Annual Report

First, I would like to thank my fellow committee members for their service this year: Bhoomi Thakore, David Embrick, David Lane, and Stephani Williams. Thanks also to Michele Koontz, Rachel Cogburn, and the Administrative Office staff for their help in compiling documents and answering questions.

The Nominations Committee is responsible for identifying the slate of candidates that, once approved by the Board of Directors, will be forwarded to the Elections Committee, who then contact each candidate to confirm interest in running for election. The Committee was able to compile their list, which hopefully will be sufficient for the Election Committee's process.

**Call for nominees** – After the initial call for nominees, certain positions did not have enough nominees (e.g., President, Anti-harassment Committee). We therefore extended the nominations period. An email was sent to the membership on June 22, 2020. At that time, there were 29 nominees. We took a different strategy this year by telling the Membership the total number of nominees to date, the number of nominees for each position, and the number we needed for each position. The extended deadline did result in a small number (4) of additional nominations (see Table 1).

**Decreasing number of nominees** – While nomination numbers continue to be low this nomination cycle, the committee would like to note this call for nominations took place during the COVID-19 pandemic. We are grateful to those who nominated themselves and to those who agreed to a nomination by another SSSP member during this trying time.

While we find appointed/ad-hoc committee participation relevant, we often discuss in what capacity the nominee has served in SSSP elected positions. We will continue to work with the Administrative Office on the logistics of the form, and include language in the e-mail reminders about completing the required requested information.
