The Board had until August 1 to finalize the resolutions and yet there has been no communication that the Board considered the proposed changes or put forward final versions of the resolutions. Did the Board consider our proposed changes? If not, why not, and why have a process that asks for proposed changes if they are not going to be considered? If so, what was the reason for not making changes? For example, the proposal to retitle the resolution "Resolution for an Academic and Cultural Boycott of Israel" seems generally noncontroversial and would provide clarity, yet the listed resolution on the website still has the same initial title.	live answered

Our resolution does not target individuals, as it states: 1. Support Palestinian academic and cultural institutions directly without requiring them to partner with Israeli counterparts as an explicit or implicit condition for such support; 2. Encourage your university and college administrations to institute funding for scholarships and fellowships for Palestinian students; 3. Refrain from participation in any form of academic and cultural cooperation, collaboration or joint projects with complicit Israeli institutions; 4. Promote divestment and disinvestment from Israel by academic institutions, and place pressure on your own institution to suspend all ties with Israeli universities, including collaborative projects, study abroad, funding and exchanges"	
27	I support the resolution as a traditional method by which organizations have supported liberation movements in the past. )	It is with horror that I see intelligent and well educated people, parroting the BDS narrative. One thing is what they say in public and another is what they actually do. You are sitting in your confortable living rooms while people are suffering by the actions of the corrupt palestinian leadership, meaning the Palestinians. You will not help the Palestinians by taking this action, on the contrary. Most Israeli scholars and society are in favor of a Palestinian state, the ones that do not want a state is the corrupt Palestinian leadership. The "boycott" "divestment" and "sanctions" will end when these 3 conditions are met: 1. "Ending [Israel's] occupation and colonization of all Arab lands and dismantling the Wall, 2. Recognizing the fundamental rights of the Arab-Palestinian citizens of Israel to full equality; and 3. Respecting, protecting and promoting the rights of Palestinian refugees to return to their homes and properties as stipulated in UN resolution 194.

This does not stop unions from striking, groups from sitting in at businesses and corporate board rooms, squatting empty buildings. We cannot put bodies on the line or withdraw our participation or support for criminal state operations without impacting business as usual. But the "targets" of this rsolution are the institutions that support oppression, not individuals.
