## CJDD Members on the Job Market

**Amanda M. Bunting** is a doctoral candidate and National Institute on Drug Abuse predoctoral trainee at the University of Kentucky. Recently recognized by the Philanthropic Educational Organization (P.E.O.) with a prestigious Scholar Award for her "ability to make a significant contribution to her field," her research examines barriers to securing employment, accessing health care, and receiving appropriate substance abuse treatment among criminal justice involved populations. Her dissertation examines important reentry and health outcomes among polysubstance using individuals following their release from prison. Interested in quantitative methodologies, Amanda uses latent class analysis in her dissertation to answer the question: How does the different polysubstance use behavior among formerly incarcerated individuals who use opioids differentially impact reentry outcomes?
