## Greenley Award Winner Announced— Peggy Thoits

We are delighted to announce this year's Greenley Award recipient, **Dr. Peggy Thoits** the Virginia L. Roberts Professor of Sociology at Indiana University where she was the first female full professor in the department. Peggy's work in the areas in social psychology, the sociology of emotions, medical sociology and, of course, social support is well known. She is a mental health scholar who impacts mainstream sociology as a leader elucidating multiple role identity theory. In fact, she has inhabited the multi-

ple roles of being a scholar, colleague, teacher, and sociologist with dedication and grace. Her work is cutting edge and thoughtful and is heavily referenced particularly articles written for the *Journal of Health and Social Behavior*, *Society and Mental Health*, and *Social Psychology Quarterly*. She will receive the Greenley award for outstanding lifetime contributions to the mental health divisions on Friday at our Divisional Meeting followed by a small post reception dinner.
