#### MESSAGE FROM OUR CHAIR

By now you will have received the call for papers for next year's conference. While there was some confusing moments during the process of determining a site for the conference, in the end a very exciting location was selected. Montreal has many attractions to offer visitors making it an excellent site for our meetings. In addition, the variety and scope of sessions being offered will provide an excellent source of discussion for members. I would like to encourage everyone to take a look at the sessions and submit papers for presentation.

I am particularly pleased with the scope of the sessions being offered by the Race and Ethnic Minorities Division. The Division is sponsoring three sessions; Stephani Williams's session on race and ethnic portrayals and the war on terrorism, Melinda Messineo's session looking at the role of political discourse in the link between race and crime, and my session focusing on the role of race and ethnicity in aging and its

potential inequalities. The session is also co-sponsoring four sessions, one with Conflict, Social Action, and Change division, a co-sponsored session with two divisions, namely Environment and Technology division and Global division, one with Poverty, Class and Inequality division, and finally, one with the Standards and Freedom of Research, Publication, and Teaching Committee.

You may have noticed, the Standards and Freedom of Research, Publication, and Teaching Committee is cosponsoring several sessions with different divisions. This is a concerted effort on the part of this committee to provide several options for discussions about the recent challenges to academic freedom brought by Horowitz and his organization.

#### ANNUAL CONFERENCE—TIPS ON TRAVELING TO CANADA

As you plan your trip to Canada for the meetings, please pay special attention to the requirements concerning travel documents.

"The easiest way to avoid delays in immigration and customs when crossing national borders is to carry an official passport from your country of origin. However, U.S. citizens are *not yet* required to carry a passport for travel between the U.S. and Canada. For U.S. citizens, a birth certificate with a raised

seal and a state-issued driver's license should be sufficient. Nonetheless, ASA does recommend that meeting attendees seriously consider getting passports to ensure their swift transit between countries for the 2006 Annual Meeting."
